## CONDITIONS OF MEMBERSHIP

**Working Bees, canteen & grounds duty:** Each family is required to complete rostered rally duty in the canteen and on the grounds, as well as attending the yearly working bees for a minimum of two 4 hour sessions. Failure to complete this request will result in the family duty of \$150 being charged on the next membership invoice. If unable to attend rostered duty, you must find a substitute and advise the canteen coordinator.

We are a volunteer organisation and while we understand that families are very busy, participation is essential for our club to continue running successfully for the children. The club would much prefer your participation than the duty levy fee.

At working bees, enter your name in the log-book in the clubhouse and report to the Grounds Manager.

**Parental Supervision:** Members who are 12 years of age or under must have a parent/guardian in attendance at all times. If you have arranged a substitute carer to supervise, you must advise the DC or Club Secretary prior to the commencement of the rally.

**Use of Grounds:** All KGPC members have the ability to use the grounds for training outside of rally days as long as the grounds are not being used by other groups. The KGARC meets between 9 & 12:30pm on Thursdays and every 2<sup>nd</sup> Sunday in the month. You are not to use the grounds at these times. At other times, members are allowed to ride at the grounds provided they are accompanied by another person. Helmets and boots as specified in PCAV uniform requirements must be worn at all times when riding.

**Code of Conduct:** Members must comply with the Codes of Conduct as determined by the Pony Club Association of Victoria (PCAV). Codes of conduct apply to Riding Members, Adult Supporters, Officials, Administrators and Coaches/Instructors.

***Violence, abuse or aggression will not be tolerated in any form on the grounds.***

KGPC follows the PCAV code of conduct at all times. At all times the safety of members and families is paramount.

Penalties for breaches of the code of conduct will be determined by the committee on a "case-by-case" basis. This may include suspension or termination of membership.
